**REPORTS OF OFFICERS**

**Calendar House Director’s Report** – Dawn Sargis reported the following.

Energy Assistance: If you have applied, get that information in to us because we are starting renters rebate applications after April 1.

The Assessor's office is accepting applications for the elderly and totally disabled home owners state program for tax relief.

ARPA projects:

Pickleball - We are waiting for a date from the contractor to finish the pickleball court this spring.

Awning – The Awning project had to be put on hold because there are issues with the studding where it attaches to the building. The building department is working with the contractor. We are waiting for some engineering drawings so we can finish that project.

Garden: We made the decision not to have the garden spaces this year. In the past few years there have not been many people participating. The person who rototills for us has a very large tractor and is not able to do a small area. We have had some people fall because the garden is soft after it is rototilled. We suggest you use the Town community garden across the street. We have applications you can fill out and bring to the town planning department.

Suggestions received:

Show the movie "Groundhog Day". We put that on the calendar for next year.

Remove the glass at the front desk since covid is over. We were given permission by the Town remove the glass by the check-in station but the rest has to remain. This has been done.

Please provide green tea which is healthier than black. We will purchase some green tea.

The handicap parking spaces are not being shoveled to the side walk. I will bring this up with the Highway Department.

Get new cornhole equipment for two sets of boards. We are going to put out a notice asking people to let us know if they are interested in playing cornhole so we can assess if the level of interest warrants an investment in purchasing new cornhole equipment.

Dawn said another thing she wanted to bring up is the library. It has been brought to her attention that some people have been leaving with bags filled with CDs, books, and puzzles. We had 63 puzzles in inventory and now we down to six. We want to remind everyone you can take out one or two to take home but you must return them. If you see someone doing something wrong, report it to the office.

A member from the floor said she came in with some donations for the Veterans Box and it was not there. She was told by an employee that people are taking the food that is put in there. Her position is if you need help with food, we have various places in town that can provide you with food. Dawn responded they should use Community Services. That is our major resource in town. There is a table in the entry way for people to drop off or take items that are free. Generally, if it is not marked free then it is not free.

**Calendar House Program Director's Report** – Liz Chubet said she spoke with a woman, Hannah Bellows, last week. She is a performing artist, classically trained in voice lessons, performing arts and script writing. She teaches at senior centers around this area. She is interested in offering some classes here. Going back to the Veterans donation box. We had to put that on pause because of the conflict. A lot of our boxes are being returned because the guys are all over the place. I want to thank everyone who has contributed.
